At the outset, the Addl. Deputy Commissioner & Nodal Officer, Karimganj elaborately briefed the discussion took place in the one day workshop on 01/02/2012 at Guwahati.

Sri G.B. Chetry, DIO (NIC), Karimganj explained power point presentation on various points on Computerization of Supply Chain Management as per discussion held in the workshop.

The Addl. Deputy Commissioner, & Nodal Officer, Karimganj explained the following subject in computerization of the system and requested to all concerned for taking immediate steps since it is time bound task.

- 1) Special drive should be made for detection/deletion of bogus ration card in GPSS area in comparison with electoral roll/census list etc and the task should be completed within Feb/2012 positively with missionary zeal.
- 2) Reason for deletion/detection of bogus F.I. Card should be indicated in the list duly certified by the concerned Area Officer.
- 3) Lifting and distribution of all PDS/TPDS items etc should be transparent upto F.P. Shop level & beneficiary.
- 4) Leakage free distribution of food grains etc should be ensured.
- 5) Identification of suitable separate room for keeping computer in GPSS offices.
- 6) To held regular review meeting about progress of the work
- 7) Numbering of trucks etc for carrying foodgrains etc in GPSS-wise and uploading the same in the District web-site.(Action DTO, Karimganj)
- 8) To appoint " Designated Officer " for liason with FCI about lifting of foodgrains by the nominees

The Deputy Director, I/C, Food Civil Supplies & Consumer Affairs, Karimganj appealed to all concerned to extend all possible co-operation in the matter so that the work be completed within Feb/2012 positively as desired by Govt. in compliance with Hon'ble Supreme Court Order.
